Jeremy Barrell is the most experienced tree risk management expert witness in the UK. Over the last two decades, in a tree context, he has acted in nine of the 16 civil cases that resulted in written judgments, five out of six criminal cases, and two inquests that resulted in Prevention of Future Deaths Reports. His most recent scientific paper is the second most downloaded paper of all time in the International Journal of Urban Forestry¹.
